Occupational therapy is provided in a small group setting

BCSSSD has a long continuing history of providing outstanding academic support services to students who attend non-public schools. The teachers and speech therapists who provide the IDEA services are the same ones who support the students under the 192/193 funding. This arrangement allows for a consistent, comprehensive educational program for students. The BCSSSD teachers and therapists (both Speech and Occupational Therapy) communicate closely with parents and classroom teachers and additionally provide a minimum of 2 written progress reports during the school year.
